- July 8 The Acting Commissioner of Finance approved the agreement to merge **FRONTENAC BANK**, Earth City, St. Louis County, Missouri, Charter No. 2862, with and into **ROYAL BANKS OF MISSOURI**, University City, St. Louis County, Missouri, Charter No. 2633 (the surviving bank), under the Articles of Agreement of **ROYAL BANKS OF MISSOURI**, with the main banking house of the surviving bank being the present main banking house of **ROYAL BANKS OF MISSOURI**, University City, St. Louis County, Missouri. Since it was determined that aforesaid banks were wholly owned by the same bank holding company, the merger took effect immediately after close of business on July 8, 2016.
- July 11 **FIRST BANK OF MISSOURI**, Gladstone, Clay County, Missouri, has returned to this office for cancellation Certificate of Authority No. 2577 which authorized a separate branch at 122 North 169 Highway (in the Big V Country Mart), Smithville, Clay County, Missouri. The bank discontinued operation of this branch on June 30, 2016. Accordingly, Certificate of Authority No. 2577 is hereafter considered to be null and void.
- July 12 Charter No. 2913 has been issued to **COLUMBIA INTERIM BANK**, 101 East Chestnut, Clarence, Shelby County, Missouri. Common Stock \$50,000; Surplus \$50,000; Undivided Profits \$-0-. The new bank will not open for business as it is an interim bank and is being formed for the sole purpose of facilitating the formation of a one-bank holding company by merger with and into **CLARENCE STATE BANK**, Clarence, Missouri, the survivor of the merger.
