- Application received from **F&M BANK AND TRUST COMPANY**, Hannibal, Marion County, Missouri, to convert its charter from a federal savings bank to a state chartered trust company.
- July 1 An application has been filed for approval of a plan of merger of **SOUTHERN BANK OF COMMERCE**, Paragould, Greene County, Arkansas, with and into **SOUTHERN BANK**, Poplar Bluff, Butler County, Missouri (the surviving bank), under the name of **SOUTHERN BANK**, Poplar Bluff, Butler County, Missouri, pursuant to which the main banking house of the surviving bank shall be the present main banking house of **SOUTHERN BANK**, Poplar Bluff, Butler County, Missouri.
