May 31 The Commissioner of Finance approved the agreement to merge **1ST BANK OF TROY**, Troy, Doniphan County, Kansas, with and into **PONY EXPRESS COMMUNITY BANK**, St. Joseph, Buchanan County, Missouri, Charter No. 2844 (the surviving bank), under the Articles of Agreement of **PONY EXPRESS COMMUNITY BANK**, with the main banking house of the surviving bank being the present main banking house of **PONY EXPRESS COMMUNITY BANK**, St. Joseph, Buchanan County, Missouri. Since it was determined that aforesaid banks were wholly owned by the same bank holding company, the merger took effect immediately after close of business on May 31, 2013.

Section 408.030 provides that the Director of Finance shall declare the quarterly market rate of interest each quarter, post it in accordance with Section 362.110 and publish it in appropriate publications. Said quarterly market rate for the period of July 1, 2013 through September 30, 2013, shall be 5.7%; as an alternative lenders may charge the usury rate of 10%.
