The Acting Commissioner of Finance approved the agreement to merge **EAGLE BANK AND TRUST COMPANY OF MISSOURI**, Hillsboro, Jefferson County, Missouri, Charter No. 124, with and into **ENTERPRISE BANK & TRUST**, Clayton, St. Louis County, Missouri, Charter No. 301 (the surviving institution), under the Articles of Agreement of **ENTERPRISE BANK & TRUST**, with the main banking house of the surviving bank being the present main banking house of **ENTERPRISE BANK & TRUST**, Clayton, St. Louis County, Missouri. Since it was determined that aforesaid banks were wholly owned by the same bank holding company, the merger took effect immediately after close of business on February 10, 2017.
